Assignment Title: provision of consultancy services for design review and construction supervision of buildings at the Institute of Accountancy Arusha – Songea campus.

1. This request for Expression of Interest follow the General Procurement Notice for this Project that appeared in United Nations Development Business (UNDB)
2. The Government of the United Republic of Tanzania through the Ministry of Education Science and Technology (MoEST) has received financing from the World Bank through the **Higher Education for Economic Transformation**

Project (HEET) in Tanzania, and intends to apply part of the proceeds for consulting services.

3. The consulting services (“the Services”) include carrying out the **provision of consultancy services for design review and construction supervision of buildings at the Institute of Accountancy Arusha – Songea campus**. The total duration for the entire assignment shall be Thirty-five (35) months whereby Six (2) months will be for design review and preparation of bidding document, Twenty one (21) months for construction and supervision and Twelve (12) months for defect liability period from contract effective date
4. The detailed Terms of reference (TOR) for the assignment are available in the following website www.iaa.ac.tz . All requests for clarification should be sent through email and the Client will send Responses to Clarifications and Amendments through https://www.iaa@iaa.ac.tz and email notification will also automatically be sent to those Consultants who have started working on this Request for Expression for Interest. The Consultants will be responsible for ensuring that any addenda available on the website is also downloaded and incorporated.
5. **The Rector of Institute of Accountancy Arusha** now invites eligible consulting firms (“Consultants”) to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The shortlisting criteria are:
 - A. **Core business and 10 years in business**
 - B. **Relevant similar experience, which should specifically include the following;**
 - 1) The firms should have at least ten (10) years’ experience in the building industry, and must have demonstrated capabilities of undertaking works of similar nature (at least one should be of educational nature), value and volume. Supporting documents of at least five (5) projects of similar nature executed by the firm within the previous ten (10) years (2011 – 2021) is vital.
 - 2) A Firm’s ability to manage at least three (3) projects of not less than the cumulative total of TZS 15 Billion delivered within expected project parameters.
 - 3) The consulting firm should be registered by recognized professional boards and authorities recognized internationally and upon commencement of the project the consultant must be registered by recognized professional boards and authorities in Tanzania.
 - 4) The consulting firm should be registered by recognized professional boards and authorities recognized internationally as Environmental expert and should have at least 5 years’ experience in conducting EIA/EA /ESIA

studies and upon commencement of the project the consultant must be registered by NEMC.

- 5) The firm must have undertaken at least three (3) Environmental and Social Impact Assessment assignments in the last five (5) cumulative years.
- 6) Experience in design and environmental systems construction and installation.

C. Technical and Managerial Capability of the Firm

The Consultant must provide the structure of the organization, general qualifications and number of Key staffs for each assignment expressed interest. (Do not provide CV of the Key staff). Key Experts will not be evaluated at the shortlisting stage).

6. The attention of interested Consultants is drawn to Section III, paragraphs, 3.14, 3.16, and 3.17 of the World Bank's "Procurement Regulations for IPF Borrowers" Fourth Edition, November 2020 ("Procurement Regulations"), setting forth the World Bank's policy on conflict of interest.
7. Consultants may associate with other firms to enhance their qualifications, but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected. Therefore, each member of JV shall independently meet the requirements of the evaluation criteria. The experience, technical & managerial capability of the Sub-Consultant shall not be evaluated to enhance the qualification of the Lead Firm or JV.
8. A Consultant will be selected in accordance with the **Consultant's Qualification Selection (CQS); method** set out in the World Bank's "Procurement Regulations for IPF Borrowers" of November 2020.
